

conditions of Participation daisy market

1. WHEN AND WHERE DOES THE DAISY MARKET TAKE PLACE?

- 1.1 *Daisy Market will be held at the ExpoCoruña fairground on 24, 25 and 26 September 2010.*
- 1.2 *The Daisy Market will be open from 12:00 to 21:30 Friday and Saturday and until 20:00 on Sunday.*
- 1.3 *Stands must remain open to visitors and attended during these times.*
- 1.4 *Exhibitors may access the Daisy Market 1 hour prior to opening times and remain there for up to 1 hour after closing time.*

2. WHAT SHOULD I DO TO TAKE PART IN THE DAISY MARKET?

- 2.1 *Fill in and send the Application Form.*
- 2.2 *The Daisy Market Organization will confirm that exhibitors have been accepted.*
- 2.3 *Once the Daisy Market Organization has confirmed exhibitor participation, the participant must send a copy of the bank transfer by fax or email. Until then the exhibition space will not be fully reserved.*

3. WHO ALLOCATES EXHIBITION SPACE?

- 3.1 *The acceptance of exhibitors is subject to approval by the Daisy Market Organization.*
- 3.2 *The Daisy Market organization will allocate stands as and when application forms and copies of bank transfers are received and other specifications (space, design).*
- 3.3 *An exhibitor will be deemed to have violated the contract if the stand or a part of the stand is ceded to a third party. Similarly, contract violation will include the exhibition or presentation of brands or makes which have not been authorised by the daisy market organising committee. When the contract is violated the exhibitor loses the right to participate in the daisy market and must pay for the stand.*

4. WHO ASSEMBLES MY STAND?

- 4.1 *The Daisy Market assembles the stands.*
- 4.2 *Exhibitors cannot alter the structure of the stands in any way.*
- 4.3 *Exhibitors cannot make holes or hammer the surface of the stands. Any damages occasioned by the exhibitor must be paid for in full by the said exhibitor.*
- 4.4 *The reception of merchandise is the responsibility of the exhibitor. Merchandise must be delivered to the stand at least two hours before the Daisy Market opening time.*

5. WHAT DO I HAVE TO DO AS DAISY MARKET EXHIBITOR?

- 5.1 *Exhibitors will attend to visitors during Daisy Market opening hours.*
- 5.2 *Merchandise remains on display while the Daisy Market is open.*
- 5.3 *Exhibitors will not disturb other exhibitors or visitors. Exhibitors will not interfere with the PA system.*
- 5.4 *Exhibitors must keep the stand in good condition.*

6. HOW AND WHEN MUST I PAY FOR MY STAND?

- 6.1 *The exhibitor must submit a single prior payment for the whole amount before the payment deadline.*
- 6.2 *Should the exhibitor fail to attend the Daisy Market, he/she loses the full Amount paid for the space.*
- 6.3 *Should the Daisy Market not take place due to unforeseen circumstances, the organization will return money paid by the exhibitor. If the event does not take place exhibitors agree that they will take no action against the organizers.*
- 6.4 *Any expenses incurred by the exhibitor for additional services contracted during the Daisy Market may be paid in cash at the time the service is contracted or by means of a single payment by bank transfer up to twenty days after the end of the Daisy Market. Payments for services of less than 100€ must be made in cash.*
- 6.5 *Exhibitors will be able to hire additional furniture and decorative elements. The Daisy Market will provide a catalogue together with an order form to be filled in. Furniture and decorative elements will be subject to availability.*
- 6.6 *Taking part in Daisy Market as an exhibitor implies the acceptance of these regulations.*
